Producer, its successors and assignees shall own all right, title and interest, including copyright, in and to the Program, containing the Licensed Material, to be used and disposed of without limitation, in perpetuity, throughout the universe, in any and all media, whether now known or hereafter developed, as Producer or its licensees or assignees shall in their sole discretion determine. Producer retains the non-exclusive right to reproduce, photograph, film, license, rent, distribute, exhibit, display, promote, broadcast or otherwise exploit the Licensed Material in connection with the Program in an original episode as well as in any ensuing repackaged episodes and in any trailers or other promotional material for the Program or any of the broadcasters of the Program. There shall be no residuals or other payments due or payable for any of the foregoing uses of the Licensed Material.

The placement and size of the Credit shall be at the sole discretion of the Producer.

The undersigned represents and warrants that it possesses or has obtained all rights and authority to the Licensed Material necessary for the grant of the rights hereunder and that the rights granted hereunder will not conflict with or violate any commitment, agreement, or understanding with any third party and will not infringe upon any rights of any person or entity.

Licensor agrees to indemnify and hold harmless the Producer, its assignees, agents, licensees and employees from and against all claims, losses, expenses and liabilities of every kind including reasonable attorney's fees and expenses, arising out of or incurred by reason of the use of the Licensed Material set forth herein or the inaccuracy, alleged breach or actual breach of any representation, warranty, covenant, agreement, or undertaking Licensor has made herein.

The undersigned's sole remedy in the event of any breach by Producer, its licensees or assignees is limited to an action at law to recover monetary damages and in no event shall Licensor have the right to obtain or seek injunctive relief against distribution or exploitation of the Program.

Producer shall have the unrestricted right to assign this agreement or any of its rights or obligations hereunder. This agreement shall be governed by the laws of the state of New York and any dispute arising under this agreement shall be resolved in a court in the County of New York.
